QWA MEMBERSHIP TYPES

QWA members are classified into the following types:

- Founders
- Business Members
 - o Entreprise Members
 - o SME Members
 - o Start-up Members
- Individual Advisory Members
- Institutional Partners

Members include both user organizations and businesses, as well as vendor and supplier organizations plus industry experts.

ENTREPRISE MEMBERS

Entreprise Members are companies who have over €100M in annual revenues.

Entreprise members pay annual dues of €10,000 and receive the following benefits:

- Be a voting member and be eligible for the Entreprise QWA Board seat in annual elections.
- 8 annual free full-meeting passes for QWA conferences
- 4 annual free entries in QWA's barcelonaqbit newsfeed
- Acknowledgement as Entreprise Member on the QWA website, collateral, conference presentations, analysts & media interviews and all other public and internal membership materials.
- Secure public speaking opportunities through the Speakers Bureau, which matches qualified member speakers with conference opportunities.
- All of the "General QWA Membership Benefits" listed above.

SME MEMBERS

Small & Medium Enterprise (SME) Members are companies who annual revenues are less than €100M but more than €10M. If the SME Member is a subsidiary of a QWA Enterprise company (revenue over €100 million), then the company must join at the Enterprise category. If the company is a subsidiary of a QWA Enterprise Member, it will automatically gain membership in the QWA at no additional charge.

SME Members pay annual dues of €3.000 and receive the following benefits:

- Be a voting member and be eligible for the SME QWA Board seat in annual elections
- 4 annual full-meeting passes for QWA conferences.
- 2 annual free entries in QWA's barcelonaqbit newsfeed.
- Acknowledgement as SME Member on the QWA website, collateral, conference presentations, analysts & media interviews and all other public and internal membership materials.
- Secure public speaking opportunities through the Speakers Bureau, which matches qualified member speakers with conference opportunities.
- All of the "General QWA Membership Benefits" listed above.

START-UP MEMBERS

Start-Up Members are companies with less than €10M revenues and/or have been founded less than 3 years before. They necessarily should not have a controlling stake by companies that fall under the definitions above of QWA Entreprise or SME members. If the company is a subsidiary of a QWA Entreprise or SME Member, it will automatically gain membership in the QWA at no additional charge.

Start-Up Members pay annual dues of €500 and receive the following benefits:

- Be a voting member and be eligible for the Start-Up QWA Board seat in annual elections.
- 2 annual full-meeting passes for QWA conferences.
- 1 annual free entries in QWA's barcelonaqbit newsfeed.
- Acknowledgement as Start-Up Member on the QWA website, collateral, conference presentations, analysts & media interviews and all other public and internal membership materials.
- Secure public speaking opportunities through the Speakers Bureau, which matches qualified member speakers with conference opportunities.
- All of the "General QWA Membership Benefits" listed above.

INDIVIDUAL ADVISORY MEMBERS

Individual Advisory Members are expert individuals that are interested in a personal membership to the QWA, which is non-transferable to third parties or companies. Individual Advisory Members require an invitation from the QWA.

Individual Advisory Members pay annual dues of €100 and receive the following benefits:
